Hartford Foundation, the Moving Forward Coalition has brought together a diverse group – nursing home residents, family members, care partners, providers, care workers, and national experts – to advance important recommendations from an April 2022 report by the National Academies of Sciences, Engineering, and Medicine. We are Driving Action Now: At the core of the Coalition's efforts are nine Action Plans. Each Action Plan describes a particular challenge facing nursing homes today, explains why it is important to residents' quality of life, defines focused goals, and provides a step-by-step path to achieve them over Year 2 of the Coalition's work. Each describes how nursing homes, state agencies, federal policymakers and others can collaborate in the short term, while also identifying core funding needs for long-term success and sustainability.

Since completing these plans in July, the Coalition is busy working to bring together the leadership, community and resources to make these initiatives a reality. And we need your help!

We are Building a Sustainable Movement: We're actively recruiting residents, family members, care partners, direct care workers, nursing home leaders, and advocates from diverse backgrounds to raise public awareness about the urgent need to address nursing home quality now.
